HOUSE OF RENTAL WOULD LIKE TO THANK YOU FOR YOUR RECENT ORDER. SINCE YOUR EVENT MAY SEE SNOWFALL, WE WOULD LIKE TO REVIEW A FEW GUIDELINES. THEY ARE AS FOLLOWS:

1. IT IS NECESSARY FOR YOU TO KEEP SNOW FROM ACCUMULATING ON TENT STRUCTURE. THIS IS ACCOMPLISHED TWO WAYS: HEAT TENT DURING CHANCE OF SNOW AND/OR BRUSH SNOW FROM TENT TOP – WE WILL SHOW YOU HOW.
2. IN THE EVENT OF DAMAGE TO OUR STRUCTURE DUE TO SNOW ACCUMULATION OR COLD WEATHER, WE REQUIRE THAT THE COST OF THE REPAIR OR THE REPLACEMENT OF DAMAGED PART OR PARTS BE YOUR RESPONSIBILITY.
3. WE ALSO REQUIRE THAT THE RESPONSIBILITY FOR ANY DAMAGE TO PERSONS OR PROPERTY IN THE EVENT OF STRUCTURE FAILURE DUE TO SAID ACCUMULATION OF SNOW ALSO BE YOUR RESPONSIBILITY.

THE STRUCTURE YOU HAVE RENTED (\_\_\_\_\_”SIZE”\_\_\_\_\_) WILL BE INSTALLED WITH THE UTMOST OF CARE KEEPING IN MIND THE TIME OF YEAR. HOWEVER, THIS STRUCTURE IS NOT SNOW RATED, SO YOU WILL NEED TO ACCEPT RESPONSIBILITY FOR CLEARING SNOW FROM OUR STRUCTURE TWENTY-FOUR HOURS A DAY.
